As set out in Annex E of the Procedural Decision Rule 6 letter, we also enclose draft versions of the remaining SoCG. Please note that the draft SoCG with South Downs National Park Authority is in a different format to the others at the request of the South Downs National Park Authority. We have been informed that the HSE and Hampshire and Isle of Wight Wildlife Trust do not wish to sign a SoCG, however, they identify no concerns with the content of the draft issued to them.

A Statement of Commonality of Statements of Common Ground is submitted as requested. We have based this on the Richborough example as that is the Example Document identified on the Planning Inspectorate's website. The Statement of Commonality records the progress of discussion on the matters set out in the Rule 6 letter

- Updated Archaeological Mitigation Strategy, both clean and tracked versions (Appendix 9.4 of the ES)


The Applicant also provides a note explaining what changes to the CoCP have been made.
