Planning Act 2008. Application by Esso Petroleum Company, Limited for Southampton to London Pipeline Response of Applicant to Deadline 3

The Applicant is pleased to enclose our submissions for Deadline 3 as set out in the Rule 8 letter.

In response to the issues raised at the Hearings, the Applicant is seeking to show a clear direction of travel on many key issues and to demonstrate that we have listened to concerns raised by the Examining Authority and Interested Parties to date. This progress is reflected in the submissions at Deadline 3 and will be further evidenced in an updated CoCP and outline documents to be submitted at Deadline 4. These will provide clarity on how construction and mitigation commitments can be implemented in line with the Application and the existing REAC. As part of these submissions the Applicant will provide further detail and additional reassurances to address the concerns raised regarding 'hotspot' areas.

In addition, the Applicant has refined the draft DCO in response to comments, including, for example, a change to working hours and modifying the requirements to reflect the submission of outline plans. Further updates are anticipated following the conclusion of discussions with the Highways Authorities at Deadline 4 over the use of their permit schemes. The Applicant will be engaging in the New Year with the relevant authorities in advance of Deadline 4 on these matters.

In our letter of 24 October 2019, we indicated that we intended to submit our formal application for a change request in respect of the temporary logistics hub sites no later than Deadline 4. We are pleased to be able to make that submission today. Details are set out below.



#### Deadline 3 documents.

#### 1. Written Summaries of Oral Submissions put at the Oral Hearings

For the Issue Specific Hearing on 27 November 2019 and the Compulsory Acquisition Hearing of the same date, the Applicant's response to the action points arising from the hearing are attached to the written oral summaries.

In the case of the Issue Specific Hearing on the draft Development Consent Order, this document also includes an Appendix 1 the Applicant's response to Interested Parties comments on the draft DCO, including those made in the Local Impact Reports.

Given the length of some of the appendices, the responses to the action points arising from the Environment Issue Specific Hearings on 3 & 4 December 2019 are separate documents to the oral summaries.

### 2. Comments on Written Representations

The Applicant has grouped together, in four separate files, the Applicant's comments on the Written Representations. Because some of the files have multiple appendices it was not possible to prepare a single file.

#### 3. An Updated Guide to the Application

An updated Guide to the Application is provided. The Applicant refers to this as the navigation document.

#### 4. An updated version of the dDCO

An updated version of the draft DCO and the Explanatory Memorandum is provided in clean, tracked and Word versions. A note explaining the changes at Deadline 3 is also provided.

#### 5. An updated Compulsory Acquisition Schedule

An updated Compulsory Acquisition schedule is provided. At Deadline 2 we provided two schedules and at the Compulsory Acquisition Hearing a third was requested. Rather than provide three different schedules with much the same information we have provided a single schedule which the Applicant believes contains all the requested information.

The Applicant is submitting two additional signed Statements of Common Ground to this Deadline with ESP Utilities Group and South East Water. We have also updated the Statement of Commonality of Statements of Common Ground.

#### 8. Miscellaneous Drawings

New drawings to support the response to the actions and comments on Written Representations are also provided. These are Alignment Sheets and Crossing Drawings supplied to assist the response to Action Point 9 following Issue Specific Hearing 3. Updated General Arrangement Plans are also provided to address the same question.

#### Change Request – Temporary Logistics Hubs

As noted above, the Applicant is now able to submit its formal written request for a change to the number of the temporary logistics hubs required to support the main construction works. The Applicant believes that this change is non-material, but the final decision on this is for the Examining Authority. In summary, the Applicant is seeking to:

- reduce the number of temporary logistics hubs from six to two;
- reduce the size of the remaining two temporary logistics hubs and amend the Order Limits; and
- convert one of the temporary logistics hubs into a smaller construction compound.

Reducing the number and size of the temporary logistics hubs is part of an updated and revised logistics approach. These proposed changes would not alter the purpose of the remaining two temporary logistics hubs, nor would it affect the route of the replacement pipeline as set out in the Application.

The Applicant carried out a public consultation on the proposed change between 5 November 2019 and 13 December 2019. Following the close of consultation the Applicant has considered the responses received.

The change request is set out in the Request for Non-Material Change: Reduction in Temporary Logistics Hubs (**document reference 8.29**)
