Thank you for consulting NatureScot about the proposed hydrogen facility (H2) at Teesside. Your contact was based on potential impacts of the development on the River Tweed SAC, the larger part of which is within Scotland. Part of the SAC is within England, however, which means that Natural England also has responsibilities for the SAC. Because the development proposal is within England, we feel that Natural England should take the lead on discussions about the proposal. We are content for them to comment on behalf of the whole SAC, although we will be happy to confer with them if they wish.
