I write following receipt of the attached letter from the Secretary of State (SoS) regarding the A38 DCO application. You may have already received a copy of this direct as it notes that it has been sent to you.

One point Highways England and WPD has been asked to clarify is contained in the letter under the heading "Article 10(4)(a)". Essentially, I think this is a simple a typo in the DCO. We meant to include Western Power Distribution (East Midlands) PLC instead of just 'Western Power Distribution'. We also meant to include WPD East Midland's company number, which is 02366923, and seem to have got this wrong too.
