Archaeological trial trenching

Highways England would like to inform the ExA that the targeted trial trenching programme agreed with Greater London Archaeology Advisory Service (GLAAS) and London of Borough of Havering has been completed and no nationally significant archaeological remains were discovered. An Interim Report summarising the findings was issued to GLAAS and London Borough of Havering which concludes that there were no notable or significant archaeological finds. This matter is recorded in the Statement of Common Ground with London Borough of Havering (item 8.1.4, page 36, TR010029/EXAM/9.8(3)) and all parties agree that the Scheme has complied with the local heritage policy DC70 Archaeology and Ancient Monuments.

Changes 5 to 8

Further to the ExA's procedural decisions given in its letters dated 5 May 2021, 26 May 2021 and 15 June 2021 to accept the requests for Changes 5 to 8 into the examination (PD-020 and PD-023), the documents numbered 34 to 68 below have been updated to incorporate Changes 5, 6, 7 and 8 into the documents submitted as part of the original application.



Highways England has also taken the opportunity at this deadline to correct errata in certain documents. These are errors which are minor in nature and do not change the meaning of documents, analysis or any assessment. The table at Annex 1 of this letter provides a list of the latest Application documents submitted at this deadline t and the reasons for the updates.
