
#### 1. Introduction


- 1.1.1 Highways England (the "Applicant") has applied to the Secretary of State for a Development Consent Order ("DCO") to authorise a scheme for alterations to M25 junction 28 (the "Scheme"). The application is submitted to the Planning Inspectorate (the "Inspectorate") in accordance with section 37 of the Planning Act 2008 (the "2008 Act").
- 1.1.2 This document comprises part of the suite of application documents and is submitted in compliance with Regulation 5(2)(0) of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009, which requires:
  - 5(2)(o) 'any other plans, drawings and sections necessary to describe the proposals for which development consent is sought, showing details of design, external appearance, and the preferred layout of structures, drainage, surface water management, means of vehicular and pedestrian access, any car parking to be provided, and means of landscaping;'
- 1.1.3 This document should be read alongside and is informed by other application documents, in particular, the draft DCO (application document TR010029/APP/3.1).







