We hold very little information on historic landfill sites and I have attached a spreadsheet of the details of the landfill sites within 3 km of Junction 10. I have also attached the details we hold for New Barn East, Camphill Tip, Silvermere Pet Cemetery and Dunsborough Farm Landfills.

Surrey County Council may hold more information on these landfill sites as we obtained most of our information either from the Waste Authorities or the County Councils when the Environment Agency was established in 1996.

Your contaminated land request has been passed on to me. A number of the sites lies outside Guildford Borough Council and you may wish to contact if Elmbridge Borough Council has information in relation to these site. The three landfill sites in Guildford are:

- 1. Land East of Buxton Wood: Planning history record shows a planning application was made (Reference: 81/P/1141) for disposal of surplus excavated material from the adjacent M25 motorway contract and subsequent restoration to agricultural use.
- 2. **Land at Pond Farm, Wisley Common**: As per the information held by this department, the land was raised using the surplus excavated material from the M25 motorway contract. According to the planning history, the land use has been for general agriculture, horse breeding and private grazing for livestock.
- 3. Dunsborough Farm, Ripley: The Site was licensed to F S Ireland Esq, Farm Manager, Church Farm, Wisley, Ripley in 1973 to accept Class 1 (a) materials excavated from land / unaltered, (b) builders rubble, brick and hardcore, and ©clinker and ash (excl pulverised fuel ash). The following waste types were excluded: cyanides, chlorates, phenols, any waste from metal finishing processes, insecticides, weed killers, acids in bulk, untreated sewage / sludge / cesspool contents, any noxious or radioactive waste, oil and petroleum products in liquid form, gas liquor and tarry wastes. Some unauthorised tipping occurred prior to licensing by Hales Construction Limited. The landfill closed in 1975.
  - Planning History: Historic use predominantly agricultural. In 1973, a planning application was made for reclamation of land for productive agricultural use by controlled tipping of materials (Planning reference: GU/R1084/9/73/RIP).

This department is not aware of any landfill gas monitoring or contaminated land intrusive investigation on any of these sites. I hope this is of help. Should you have any further gueries, please do not hesitate to contact.

Hi XXXXXX,

Unfortunately I have been out of the office for the vast majority of this week, so I have had limited time to look at this. I have attached what I have found so far and I will continue to look for details of the tips/landfills that I have not included here.

There are two sites that I have failed to find any mention of at all within our records. These are Old Rectory Farm and Dunsborough Farm Landfills.

Have you looked at the Environment Agency and they're historic landfills map? I realise that this is quite likely where you found the sites in the first place, but if not, it would be a very worthwhile pursuit of time to find out what information they hold on each site. This is often where information is held on historic sites if we as the local authority do not have it.

The other issue I'm having is that there is no enforcement information on these sites. This means that I cannot verify that what was proposed in decision notices, statements of intent or committee reports was actually adhered to. Planning decisions were not necessarily enforced as well and as closely as they are today.

As I say, I will come back to you with further information on the additional sites next week.

Land at East of Buxton Wood	Guildford Borough Council	Planning history records for Land at East of Buxton Wood shows a planning application was made for disposal of surplus excavated material from the adjacent M25 motorway contract and subsequent restoration to agricultural use.
	Surrey County Council	The landfill had a capacity of 60,000 cubic metres and a depth of approximately 2.0 metres. The facility would he used for two years commencing with topsoil stripping, filling, and then re-soiling and seeding for agricultural use.
Land at Pond Farm	Guildford Borough Council	The landfill was raised using surplus excavated material from the M25 motorway contract. The land was subsequently used for general agriculture, horse breeding, and private livestock grazing.
Pointers Farm	Surrey County Council	A first schedule dated October 18, 1981 was provided by the Council. The landfill was planned to be used for 20,000 cubic metres of surplus excavated materials arising from the construction of the M25, Chertsey-Wisley section. The area was to be subsequently reinstated as 1.4 ha (3.45 hectares) of agricultural land.  A second Schedule states that the permission for Pointers Farm tipping and its reinstatement expired one year after the Chertsey-Wisley section of the M25 Motorway was opened to public traffic. The site was to be used exclusively for excess spoil material excavated from the line of the M25 between the proposed New Haw viaduct and Ockham Lane. The schedule stated that the landfill shall not be used for tipping of any other materials whatsoever.
Chatley Farm	Surrey County Council	When the landfill was proposed it was to be used for tipping of surplus material from the M25 and the area was subsequently restored to agricultural use. The landfill was operated by Balfour Beatty and opened in 1982.  In the process of constructing the M25 motorway, Balfour Beatty encountered a greater quantity of unsuitable material than anticipated. To limit costs, both financial and environmental, the material was disposed as close to the M25 as possible. Approximately 50-75,000 cubic metres of unsuitable material from the M25 was to be deposited within the landfill. However, the extents of the landfill were subject to information regarding the precise boundary of the floodplain and the need to protect three oak trees within the area.  Tipping permission expired on 30 September 1984 or a year after the Chertsey-Wisley portion of the M25 motorway was open to the public.
General Comments	Guildford Borough Council	The historical use of the area surrounding the Scheme was predominantly agricultural and in 1973, a planning application was made for reclamation of land used by controlled tipping for productive agriculture (Planning reference: GU/R1084/9/73/RIP). Guildford Council is not aware of any landfill gas monitoring or contaminated land intrusive investigations on any of these sites.
	Surrey County Council	Old Rectory Farm and Dunsborough Farm Landfills are not mentioned in any of the Surrey County Council records.

I have spoken to both of the technical specialists about your query ( — Thames; — Thames; — KSL) and neither of them anticipate any showstopper issues emerging from the GI based on what they have seen so far, and are both satisfied that any issues can be dealt with adequately through any requirements on the DCO.

We therefore raise no issues with the proposal to submit the DCO application prior to the completion of the GI reporting. Please note that this opinion is based on land and groundwater issues within our remit. W would also advise you to contact other relevant consultees or parties, including the local authorities and water companies, for their views on your proposals.
