Section 51 advice regarding Evidence Plan process

Thank you for your enquiry about the Evidence Plan process. I write to set out the background to the process and the role that the Inspectorate has in it.

The Evidence Plan process arises from the commitment in the Habitats and Wild Birds Directive implementation review, and is a formal mechanism to help ensure compliance with the 'Habitats Regulations' (the Conservation of Habitats and Species Regulations 2017).

Evidence plans have a strong uptake amongst NSIP applicants and can facilitate the resolution of Habitats Regulations issues. At the heart of the process is detailed engagement with the relevant statutory nature conservation bodies, in order to reach a clear understanding of the position on these issues by the time of application (and on Environmental Impact Assessment issues given the overlap between this process and Habitats Regulations Assessment). The outcomes of the evidence plan process can contribute to the preparation of Statements of Common Ground (SoCG) with the parties involved.

Essentially the process involves regular meetings, which include both topic specific meetings as necessary and overview 'Steering Group' meetings. We offer attendance and a 'chairperson' role for the Steering Group meetings. The specifics of the process are flexible and will depend on the issues involved, and naturally there is scope for the process to evolve as it progresses, in order to ensure proportionality and maximise the value of the Inspectorate's involvement. Part of our role is to publish a meeting note to record attendees, location of meeting, agenda items, and a summary of any s.51 Advice provided.

I would like to draw to your attention our pre-application prospectus, which is
