**The A122 (Lower Thames Crossing) Development Consent Order 2025 – Application for a Non Material Change under Schedule 6 to the Planning Act 2008 – (Application NMC-2)**

**1 Proposed Non-Material Change Application**

- 1.1 In March 2025, the Secretary of State for Transport made the DCO authorising the construction and operation of the authorised development of the A122 (**Lower Thames Crossing**). The DCO came into force on 15 April 2025.
- 1.2 National Highways (the **Applicant**) is now proposing to apply to the Secretary of State to make two non-material changes to the DCO in accordance with the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011, as amended (**2011 Regulations**). This application (**Application NMC-2**) sets out Non-Material Change Application 2.

**Non-Material Change Application 2 – NMC-2**

- 1.3 Application NMC-2 comprises modification of the wording of Article 65 of the DCO in relation to the requirement for a financial contribution to be made available by National Highways for the benefit of the Kent Downs National Landscape, with the intent of changing the time requirements for agreement to be reached. The proposed amendment would link the timing for reaching agreement of the financial contribution to commencement of works south of the River Thames, instead commencement of works anywhere within the Order limits.

**Application**

- 1.4 Accompanying this application are:
- a. a Supporting Statement, setting out details of the change being applied for; and

- b. a draft Amendment Order which would implement the amendment proposed to reflect the change sought; and
- c. a copy of the Regulation 6 Notice.

#### **Regulation 4 compliance**

- 1.5 Compliance with the requirements of regulation 4 of the 2011 Regulations is set out in Annex A - Compliance with Regulation 4 of the 2011 Regulations.

#### **Consultation**

- 1.6 The consultation period will run between **18 September 2025 and 23:59 on 23 October 2025**. - 1.7 The Regulation 6 Notice will be published in the Kent Messenger on **Thursday 18 September** and **Thursday 25 September 2025**.
