Guidance on submitting a Relevant Representation for the Lower Thames Crossing NSIP application

The Planning Inspectorate has issued the following advice for those who wish to make a Relevant Representation in order to register to take part in the examination into the Lower Thames Crossing NSIP application.

How to access the form

You can access the form via the Blue Register online button or the Registration form

tab on the <u>LTC project page</u>. If you are viewing the page on a small screen or with large text you may need to scroll down the page to get to the form.

If the form does not load properly or fails to submit, please refresh the page in the first instance.


What to include in the 'Your Representation' box

In accordance with Regulation 4 of The Infrastructure Planning (Interested Parties and Miscellaneous Prescribed Provisions) Regulations 2015, you **must** provide an *outline* of the main points you intend to make in relation to the application. You will get a chance to submit a more detailed representation later in the examination. This outline need only be a few lines or bullet points stating your view and/or main issue(s), benefit(s) or concern(s) in relation to the proposed scheme. See Figure 3 below.

If you do not include this in your representation, we will <u>not</u> accept your form and you will therefore <u>not</u> be registered to take part in the examination. In these circumstances we will attempt to contact you, usually by email via the address you provide on the form. As long as the Relevant Representations period is still open you will get the opportunity to add to your representation to make it valid and complete your registration.

Important note: the Relevant Representations period closes at <u>23:59 on Friday 24 February 2023</u>, however the case team do not work outside of standard office hours, therefore if an

invalid submission is made after 5pm on Friday 24 February it is very unlikely that you will be notified to be able to rectify it before the close of the Relevant Representations period.
