An update to 9.35 Schedule of Progress in relation to S127 and S138 (REP3-017) is not provided at this deadline as there has been no progress to report.

In National Highways' Written summary of Applicant's case at Compulsory Acquisition Hearing 1 (REP4-007) at Item 5(c) a commitment was made to prepare a report for submission at Deadline 5 which sets out the likely impacts of the construction of the proposed Mottram Underpass and the associated long term ground water drawdown effects on Craig Dean, 21A Old Road. However due to the complexities involved, and National Highways' commitment to share the results of the study with the owner of the property and her family prior to submission, National Highways is not in a position to submit this report into examination at Deadline 5. The report will therefore be submitted into examination at Deadline 6.

In National Highways' Written summary of Applicant's case at Issue Specific Hearing 2 (REP4-008) at Item 4(y) a commitment was made to provide the contents of a design approach document. These contents are set out in Annex 1 to this letter.
