The Marine Management Organisation (MMO) has reviewed the Examining Authority's (ExA) 'Rule 8 Letter', dated 16 April 2019.

- Notification by Statutory Parties of their wish to be considered as an Interested Party (IP) by the ExA
- Summaries of all Relevant Representations (RRs) exceeding 1500 words

# Notification by the MMO to be considered as an Interested Party by the ExA

The MMO has an interest in this project because the works, as detailed within the Environmental Statement (ES), appear to include construction activities which are proposed to take place within the UK Marine Area (as defined by Section 42 of the Marine and Coastal Access Act – MCAA 2009). The Development Consent Order (DCO) application includes a draft Deemed Marine Licence (DML) under Section 65, MCAA. Should consent be granted for the project, the MMO will be responsible for monitoring, compliance and enforcement of DML conditions.







# Summaries of all RRs exceeding 1500 words

The MMO submitted a Relevant Representation in response to section 56 of the Planning Act 2008 (as amended) on 04 April 2019. The key points within the Representation are summarised below:

- We identified that we wish to be considered as an IP by the ExA
- We provided a summary of pre-application engagement with the Applicant.
- The MMO provided comments on the Environmental Statement. No major concerns were raised in consideration of the relatively minor marine aspects to the project.
- The MMO provided comments on the draft DCO and DML. Detailed comments were provided regarding amendments to the draft DML wording and requirement for additional conditions.

#### Other matters

Following a review of all Relevant Representations submitted to the ExA, the MMO has no comments to make. The MMO is not aware of any updated application documents or additional information as yet submitted to the ExA that holds relevance to its remit.

It is anticipated that subsequent updates to the draft DCO documents submitted to the ExA will satisfactorily address the MMO's previous comments.
