#### 1 INTRODUCTION

#### 1.1 Introduction

- 1.1.1 This document provides a guide to Highways England's A585 Windy Harbour to Skippool Improvement Scheme (the Scheme) Development Consent Order (DCO) application pursuant to the Planning Act 2008. The original application was submitted to the Planning Inspectorate on the 29 October 2018, and accepted for examination by the Examining Authority on 26 November 2018.
- 1.1.2 Since submission, a number of the original application documents have been revised and new documents produced. This guide charts the submission of these documents to the Planning Inspectorate. This is a live document and will be updated throughout the examination period and submitted, when updated, for each deadline.

#### 1.2 Master Document List

8	Statements of Common Ground	Additional documents that support the DCO application and have been produced to confirm to the Examining Authority where agreement has been reached between the Applicant and various interested organisation. The Statements of Common Ground reflect those required as part of the Rule 6 letter.
