**A303 Sparkford to Ilchester Dualling Development Consent Order – Non-Material Change Clarification**

We wrote to you on 8 March 2019 (letter reference: HE551507-MMSJV-LSI-000-CO-UU-0002) requesting a non-material change and as part of this, we requested that plot 7/5a was changed from "*Land to Be Used Temporarily and Rights to be Acquired Permanently*" to "*Land to be Permanently Acquired*". This was an error, and plot 7/5a should remain as "*Land to Be Used Temporarily and Rights to be Acquired Permanently*". Please disregard the request to change the status of plot 7/5a.
