3.7.4	The Applicant	Parallel Road	Correction – The PCs have never suggested that provision of a Parallel Road would not require the Steart Hill overbridge. What was suggested in Mr Philip Gamble's submission was that provision of a LPR would obviate the need to provide an East Bound junction at Downhead. The cost savings cited by the PCs and other IPs come from less disruption to A303 traffic and a clear work site which would in turn remove the need to construct temporary haul routes north and south of the existing A303 and provision of the temporary Bailey Bridge by the proposed Steart Hill overbridge. Other benefits come from built in resilience and future proofing the scheme if / when this section of the A303 becomes an 'Expressway' by providing a route for barred NMU and Agricultural vehicles.
3.7.7	The Applicant SSC SSDC Parish Councils	Traffic Monitoring and Mitigation	The Parish Councils vehemently dispute H.E.'s baseline assumptions that suggest current traffic levels are at an acceptable level – they clearly are not. Designing a scheme that continues to direct traffic onto (in West Camel's case) unclassified roads and then seeks to increase traffic flows is NOT acceptable. Similarly in Sparkford and Queen Camel High Streets it is not unreasonable to expect traffic levels to decrease post scheme rather than planned, intentional increases. H.E. made a formal offer to West Camel PC in the presence of our MP (May 2018) to fund a Traffic Calming scheme from their 'Discretionary Funds', which we expect them to offer. Similarly it is not unreasonable to expect that the same source of funding be used to provide and improve Traffic Calming in both Sparkford and Queen Camel High Streets. Extensive Monitoring has already been carried out by H.E. and SCC. We now need a firm undertaking from H.E. to fund mitigation in all three villages.

I am writing to you on behalf of the three Parish Councils of Queen Camel, West Camel and Sparkford in order to solicit your support for the provision of a Local Parallel Road i.e. linking up the de-trucked sections of the old A303 to create a local road running parallel with the proposed dual carriageway.

Although in previous incarnations of the current scheme, the then Consulting Engineers planned for retention of a parallel road, the current designers Matt-MacDonald claim that they would need to acquire a strip of land from the edge of your Camel Hill Site (approx 2m x 90m).
