**Deadline 9 Update to Book of Reference**

Following a review of the latest land registry information in December 2021 and receipt of evidence from parties with land interests, the following documents have been updated. No changes were required to document '2.3 Land Plans, Rev.2' (**REP5-002**).

Where new parties have been added, we have issued S102 notices and actively engaged with them, including site meetings with some parties. As discussed with the Examining Authority's Case Manager, we will separately provide a summary note of all the name and

address changes to inform their review of contact details for interested parties and confirm the evidence for the changes.

### **Deadline 8 Update to DCO Plans**

The following updated DCO plans have also been submitted due to minor error corrections, as outlined below:

- Updated 2.11 Classification of Roads Plans, Rev.3 (**REP8-005**). Drawing sheet 16 was updated to correct an error by moving a label to make the end of the trunk road visible.
- Updated 2.6 Traffic Regulation Plans, Rev.3 (**AS-030**). Drawing sheet 1 was updated to correct a missing label in the pdf version.
- Updated 2.12 Hedgerow Plans, Rev.3 (**REP8-006**). Drawing sheet 6 was updated to correct an error by removing a rogue text box.

- 8.7 Statement of Common Ground with South Norfolk Council, Rev.2 (**REP7-013**) – tracked changes and clean versions.

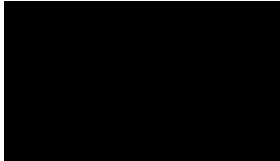
The following have been submitted with updates and as final versions:
