Regarding Sutton / Wansford Rd Station

Dear Mr S Falco

Writing to seek your opinion on the subject of planning as the officer for PCC on Historic Built Environment. The final plans of the dualling of the A47 from Wansford to Sutton roundabout has recently been forward to PINS, and the new route will result in the removal of the station masters house and part of the platform as part of the scheme. The building is on the list of Heritage Assets as a collection of 3 structures, Heath House, Angled railway bridge and the building in question. It is a beautiful building mostly intact with most of its original features see enclosed pictures. When the A47 was widened at Milton Ferry, the stone building (toll house) was removed from near the bridge and relocated at the top of the embankment overlooking Ferry Meadows and the new road, and with this idea I put forward a proposal to Highways England to do something similar which they are presently looking at these options.

The plan is to relocate from the northern side to the southern side of the rail bridge alongside the track, and also to bring it back into public use with an element of the building being used as environment classroom and other community groups, with disabled user friendly facilities. Potential with Peterborough University course studies with the nearby River Nene and county wildlife site supporting woodland and rare limestone flora. Connection would be made via the new much improved cycleway and walkway that is part of the road scheme giving great connectivity using the old railway bridge both over and underside. The Landyke Trust and its members held a site meeting and have uses for the building and very supportive.

This is an unusual situation for all of us, which is an opportunity for all of us and would be a shame if missed from both a public element, but also environmental and historical. I understand it is technically a new build in open countryside, however feel as others this has merit taken in context with some of the points mentioned above. Daniel Worley is representing PCC and is sitting in on the meetings with Highways England on this proposal and NVR proposal and would be able to supply further information.

What would be helpful to ourselves and Highways England if the planning department would be in principle supportive of our scheme, subject to further in-depth planning application being submitted? This would help Highways England reach an opinion on what proposal they would support. Your website is presently showing non acceptance of preplanning applications due to the situation the country is coming out of and high workloads, it's also difficult to put in for planning on the back of a road scheme that is also awaiting planning. But in the coming weeks Highways England will want to make a decision on the relocation of the station and it would be good to know your opinion. Have also enclosed some pictures and more than welcome to do a site visit if it helps to understand this unique application. Please do not hesitate if your team requires more information, thank you for your time on this.

A few weeks ago we sent you a letter to ask if the Sutton Station proposal would have merit by PCC planning to a relocation from north to south of the present A47 bridge which is to be retained as a WHCER route. This would still be subject to a fully documented planning application process, but to assist Highways England and ourselves we would like to know if Peterborough Planning would consider if this scheme has merit.

I am enclosing a more updated relocation plan which shows greater detail of the proposal, and also a data stick with a copy of the files sent for DCO submission.

The building will have a public element as it was originally built for by the public using the Bread and Onion Line as it was known.

Do let me know if you wish to visit the site, or speak to Daniel as I know he is familiar with the site and location.

Thank you for your email, and reason for getting in touch with you is to see if you can assist with any of your contacts with PCC planning.

The scheme we have submitted to Highways England is for the rail buildings to be relocated to the southern side of the rail bridge, but what would be helpful is if PCC planning indicated this scheme has "merit" within planning scope and to give Highways England confidence to back this idea. The building would have an environmental classroom with facilities which links into the surrounding area, with cycle route under the old rail bridge. Hoping if you have good connections with Daniel to convince him of the benefits, as unfortunately I feel he is more in favour of the NVR scheme. I should just like to put on record the support of the Langdyke Countryside Trust and other partners in the John Clare Countryside Partnership for the idea that Robbie Reid outlines below. We hope that it can be looked at within the context of our plans to support the Doubling Nature and Access to Nature objectives across the rural areas west of Peterborough, recognising the Council's stated support for the JCC Project.

We are in the process of drawing up detailed ideas for a John Clare heritage trail, incorporating elements of the Green Wheel and Torpel and Hereward Ways, linking up key points of historical, heritage and wildlife interest, including the Bronze Age history from Etton-Maxey, Roman remains at Castor, John Clare's Cottage, Swaddywell Pit, Upton chapel, the village churches, Burghley and Milton Parks. How are you and hope you are well. Also thank you for the site meeting we held a while ago to give you some perspective into the relocation and the road scheme.

I am writing to find out the view point PCC planners have arrived at on our application as time is marching on and the relocation is now a question with the planning inspectorate submissions. It's also as an update on the Sutton parish council agenda and Highways England are still waiting so to sort designated funding. They are commencing the detailed surveys at the end of January mainly for services but also the banks of the rail cutting. It would be good to get a reply so we can move forward. We understand these last few months have not been easy and time is at a premium but all of us would like to move this forward to the next stage.

It was interesting to note the PCC submission to the Planning Inspectorate, which I think was written by J MacLennan, about the collection of buildings being kept within close proximity to each other but also very pleased about Peterborough seeing the importance of the wildlife corridor between Sutton Heath SSSI and our land that feeds into Nene Park Trust land.



Thank you for your pre-application enquiry received on 1 October 2021, in respect of the above site. I write to provide advice regarding your proposal.

Proposal

I understand that you wish to re-locate the disused station from its current Wansford Road siting to approximately 150 metres south of its current siting, on land that is the south of the A47. The station would be re-used to serve a multitude of community uses, such as a classroom space, as well as provide accommodation to persons 'protecting the asset'. One of the existing buildings would be retained on the current siting to host a bat roost.

Background - Development Consent Order relating to A47 expansion

Beyond the scope of this pre-application, the Local Planning Authority is aware of an application being assessed by the Planning Inspectorate with regards to expanding the A47 infrastructure from Wansford and covering land north of Sutton. This reference is TR010039. The expansion impacts upon the siting of the current station and it is understood that the station's removal has already been accepted. This pre-application represents one of the proposals and only focuses upon the impacts of the proposed relocation.
