1 INTRODUCTION

- 1.1.1 The Development Consent Order (**DCO**) application for the A47 Wansford to Sutton Scheme was submitted on 5 July 2021 and accepted for examination on 2 August 2021.
- 1.1.2 The purpose of Table 1.1 in this document is to set out the changes made to the draft Development Consent Order (**dDCO**) from that submitted on 5 July 2021 (Version 0) (**APP-017**).
- 1.1.3 These changes were made principally in response to comments and recommendations made to the Applicant before the start of Examination.
- 1.1.4 The purpose of Table 1.2 in this document is to set out the changes made to the draft Development Consent Order (**dDCO**) from that submitted on 13 August 2021 (Version 1) (**AS-010**).
- 1.1.5 These changes were made principally in response to the Examining Authority's written questions and requests for information (ExQ1) (**PD-008**) and queries explored at Issue Specific Hearing 1 (**ISH1**) which took place on 12 January 2022.
- 1.1.6 The purpose of Table 1.3 in this document is to set out the changes made to the draft Development Consent Order (**dDCO**) from that submitted on 1 March 2022 (Version 2) (**REP3-003**).
- 1.1.7 These changes were made principally in response to queries explored at Issue Specific Hearing 4 (**ISH4**) which took place on 17 March 2022.
- 1.1.8 The purpose of Table 1.4 in this document is to set out the changes made to the draft Development Consent Order (**dDCO**) from that submitted on 28 March 2022 (Version 3) (**REP4-002**).
- 1.1.9 These changes were made principally in response to the Examining Authority's further written questions (**ExQ2**) (**PD-010**).
- 1.1.10 The purpose of Table 1.5 in this document is to set out the changes made to the draft Development Consent Order (**dDCO**) from that submitted on 20 April 2022 (Version 4) (**REP5-005**).
- 1.1.11 These changes were made principally in response to the Examining Authority's Proposed Changes to the draft Development Consent Order (**PD-014**) and to the Examining Authority's Further Written Questions (**ExQ3**) (**PD-015**).
- 1.1.12 The purpose of Table 1.6 in this document is to set out the changes made to the draft Development Consent Order (**dDCO**) from that submitted on 14 June 2022 (Version 4) (**REP8-033**).
- 1.1.13 The changes were made to bring article 16 into line with the A47 Blofield to North Burlingham Order (as made on 22 June 2022) and, in Schedule 9 (Protective Provisions), to update Parts 1 and 2 and incorporate new Parts 3-6.
- 1.1.14 The purpose of Table 1.7 in this document is to set out the changes made to the draft Development Consent Order (**dDCO**) from that submitted on 28 June 2022 (Version 6) (**REP9-002**).
- 1.1.15 It is submitted together with:
 - a revised version of the dDCO (Version 7); and

- a comparison version of the dDCO showing all changes between new Version 7 and Version 6.
- 1.1.16 The changes were made principally in accordance with paragraph 147 of the Secretary of State's decision letter for the A47 Blofield to North Burlingham Order (as made on 22 June 2022) and, in Schedule 9 (Protective Provisions), to update Part 3 following consultation with the Environment Agency.
- 1.1.17 The purpose of Table 1.8 in this document is to set out the changes made to the draft Development Consent Order (dDCO) from that submitted on 6 July 2022 (Version 7) (REP10-005).
- 1.1.18 It is submitted together with:
- a revised version of the dDCO (Version 8); and
 - a comparison version of the dDCO showing all changes between new Version 8 and Version 7.
- 1.1.19 The changes were made in response to paragraph 147 of the Secretary of State's decision letter for the A47 Blofield to North Burlingham Order (as made on 22 June 2022).
