Planning Act 2008 (as amended) and the Infrastructure Planning (Examination Procedure) Rules 2010

Application by Norfolk County Council ("the Applicant") for an Order granting development consent to construct a new crossing of the River Yare in Great Yarmouth. The scheme would consist of new dual carriageway road, including a road bridge across the river, linking the A47 at Harfrey's Roundabout on the western side of the river to the A1243 South Denes Road on the eastern side ("the Proposed Development").

# REQUEST FOR COMMENTS FROM THE APPLICANT, ENVIRONMENT AGENCY, GREAT YARMOUTH PORT AUTHORITY ("GYPA") AND GREAT YARMOUTH PORT COMPANY ("GYPC")

The Examining Authority submitted on 24 June 2020 a Report and Recommendation in respect of its findings on the above application to the Secretary of State for Transport ("the Secretary of State"). In accordance with section 107 of the Planning Act 2008, the Secretary of State has until 24 September 2020 to make a decision on the application. The Secretary of State would be grateful if the Applicant and other affected parties where highlighted in bold could provide comments on the matters set out below.

## **Environment Agency**

The Secretary of State notes that the Environment Agency has confirmed in their post examination correspondence attached in Appendix A that the protective provisions are now agreed.

Please could the **Applicant** and the **Environment Agency** provide the Secretary of State with the final agreed version of the protective provisions?

#### **GYPA / GYPC**

From the late representation attached in Appendix B, the Secretary of State notes that the side agreement between the **Applicant** and **GYPA/GYPC** is now complete. The Secretary of State further notes at paragraph 2.2.2 of the Applicant's Addendum to Closing Statement [AS-026] that once the agreement has been completed, the Applicant will provide further amendments to the draft DCO.

Please would the **Applicant**, **GYPA and GYPC** confirm whether, in the light the conclusion of the legal agreement, the parties still intend to provide amended DCO drafting. If revisions to the DCO are being sought, please would the Applicant provide the relevant amendments that relate to the protective provisions in Part 6 of Schedule 14, and to article 3 of the proposed DCO. Confirmation that both GYPA and GYPC agree with the revisions sought should be provided along with any drafting submitted.

### The deadline for any response is 4 August 2020.
