1 DMRB GUIDANCE

1.1.1. The Design Manual for Roads and Bridges (DMRB), including any Interim Advice Notes (IANs), has been used as the main source of guidance for the Environmental Impact Assessment (EIA) for the Scheme. Some DMRB guidance documents were updated in 2019 and 2020 (and associated IANs replaced), by which time the EIA for the Scheme was largely complete. **Table 1-1** details the former DMRB guidance on which the original EIA was based, including a link to the archived DMRB guidance documents, as well as details on the updated relevant DMRB guidance.
