there are two approaches, there are some areas where there are no significant effects identified such as the river kokott area, but there are some veteran trees, notably t six eight to Mt 701. And it has now been agreed that compensation will be provided for those and also compensation for impacts on our wood and well wood is to be secured by an agreement between the body that manages those two words, which is Northumberland county council and highways England. So

And so the use of culverts though, and mammal shelves in them, things like that, where they're available, they do provide some opportunity for creatures to to cross the cross the road. And so ecology is very much taken into account in the design of schemes.

Then the next question you asked was about diversion through Hebron. Now, the this is something again, which housing does as you can well imagine very much takes into account when it's designing

schemes and the objective is to keep the main line of the road open. Throughout meeting that there wouldn't be exception very exceptional circumstances or diversion off the main mind. There are some occasions where that might happen where for instance, there overnight bridge works that would be taking place taking place, which could not take place whilst keeping the main line of the road open. But in most cases, there wouldn't be a major diversion from the main line of the road. And that brings us on to your question about working hours now, to ensure that a project is large and complex as this is properly taken, properly considered and taken into account that the
