Appendix C.4 to C.5 show traffic flows in additional locations for which queries were received during the consultation process.



Appendices C.7 to C.12 show the same information, but for the year 2042.




C.1 2027 traffic flows for locations provided during consultation (1)






C.2 2027 traffic flows for locations provided during consultation (2)






C.3 2027 traffic flows for locations provided during consultation (3)








C.5 2027 traffic flows for additional points requested during consultation (2)






C.6 2027 A12 mainline












