1 Introduction

1.1 General

- 1.1.1 National Highways (the Applicant) has submitted an application under section 37 of the Planning Act 2008 (the "2008 Act") to the Secretary of State for Transport via the Planning Inspectorate (the Inspectorate) for an order to grant development consent for the A12 Chelmsford to A120 widening scheme (the proposed scheme).
- 1.1.2 The Examing Authority (ExA) have requested for addition plans to be created for Deadline 1 to show key details including
 - the existing A12 route;
 - the proposed route and junctions;
 - work no. U69 diversion of high pressure gas pipeline showing:
 - o existing gas main;
 - o proposed gas main;
 - the parcels of land with plot numbers affected by compulsory acquisition;
 - the parcels of land with plot numbers affected by temporary possession; and
 - the scheme limits
