The Applicant has resubmitted all plans, drawings and figures submitted with the application with a low resolution as requested by the Examination Authority on the Regulation 6 Letter to aid examination.

At the Preliminary Meeting we proposed to provide a validated dDCO at Deadline 1. As a dDCO revised draft will now accompany our Deadline 2 submissions we have not provided a validated dDCO at Deadline 1.
