# TR010064 - M60/M62/M66 Simister Island Interchange EXAMINATION DEADLINE 6 SUBMISSIONS

This submission is made by National Highways (the "Applicant") in accordance with the examination timetable set out in the Rule 8 letter [PD-009] published by the Examining Authority (ExA) on 17 September 2024. The Applicant has prepared a number of documents requested by the ExA for Deadline 6 of the Examination. A short summary of each document is provided under the subheadings below.

## **Design Principles Report**

The Design Principles Report (TR010064/APP/7.29) has been prepared in response to Issue Specific Hearing 2 (ISH2) Action Point 11, identified in the ExAs Action Points arising from ISH2 on environmental matters held on Wednesday and Thursday 28 November 2024. The Design Principles Report (TR010064/APP/7.29) sets out how the Scheme's Design Principles will be secured and delivered through the detailed design of the Scheme. Bury Metropolitan Borough Council has had sight of the structure and content of the Design Principles Report through its development.

# Comments on any further information/submission received by Deadline 5

Iteration Environmental Management Plan [REP5-023] to include an additional commitment, reference G11.

# **Outline Traffic Management Plan [APP-150]**

In responding to the request for further information (our reference R.19) relating to securing of joint inspection of work locations with Bury Metropolitan Borough Council and any remedial works, the Applicant has updated the Outline Traffic Management Plan [APP-150] to include an additional paragraph (5.6.6) clarifying the responsibilities of the Principal Contractor in this regard.

## The Applicant's updates (Rule 6 letter Annex E) [REP5-026]

In responding to the request for further information relating to Individual Objections to Compulsory Acquisition (our reference R.7) and Protective Provisions for Statutory Undertakers (our reference R.14 and R.17) the Applicant has provided corresponding updates to 'The Applicant's updates (Rule 6 letter Annex E)' [REP5-026]. The Applicant draws the ExA's attention to the response received form the Department for Education (enclosed at internal Appendix C) confirming that it does not hold a Crown Interest in land within the Order Limits. The Applicant will make corresponding updates to the application documentation to remove refences to Crown Land and provide those updates at Deadline 7.

# Report on the Implications for European Sites

The Applicant notes the ExA's Report on the Implications for European Sites [PD-014] dated 14 January 2025. The Applicant has no further comments.

# **Environmental Statement Appendix 7.5 Arboricultural Impact Assessment [APP-086]**

The Applicant has submitted a revision of the Appendix 7.5 Arboricultural Impact Assessment of the Environmental Statement Appendices [APP-086] to make a correction to the site clearance data used to ensure it is in alignment with the assessment undertaken and related documents in the Environmental Statement. These revisions have not affected the overall assessment conclusions.
