1 Introduction

1.1 Purpose of this document

- 1.1.1 These Land Plans (the "Plans") relate to an application made by National Highways (the "Applicant") to the Secretary of State for Transport via the Planning Inspectorate (the "Inspectorate") under the Planning Act 2008 (the "2008 Act") for a Development Consent Order (DCO). If made, the DCO would grant consent for the M60 J18 Simister Island Interchange (the "Scheme").
