We hope to be able to confirm agreement with the Application on Network Rail's preferred form of Protective Provisions, by deadline 9, 7 April 2025.

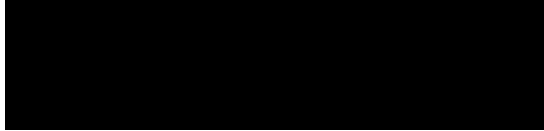


