**The A46 Newark Bypass Development Consent (Correction) Order
2026**

Made - - - - - *9th January 2026*
Coming into force - - - *12th January 2026*

The A46 Newark Bypass Development Consent Order 2025 (“the 2025 Order”)(a), which granted development consent within the meaning of the Planning Act 2008 (“the Act”)(b), contained correctable errors as defined in paragraph 1(3) of Schedule 4 to the Act.

In accordance with paragraph 1(5)(a) of Schedule 4 to the Act, before the end of the relevant period, as defined in paragraph 1(6)(a) of Schedule 4 to the Act, the Secretary of State received a written request from the applicant(c) for the correction of errors and omissions in the 2025 Order.

In accordance with paragraph 1(7) of Schedule 4 to the Act, the Secretary of State has informed the relevant local planning authorities that the request has been received.

The Secretary of State, in exercise of the powers conferred by section 119 of, and paragraph 1(4) and (8) of Schedule 4 to, the Act, makes the following Order.

Citation and commencement

1. This Order may be cited as the A46 Newark Bypass Development Consent (Correction) Order 2026 and comes into force on 12th January 2026.

Corrections to the A46 Newark Bypass Development Consent Order 2025

2. The A46 Newark Bypass Development Consent Order 2025 is corrected as set out in the table in the Schedule of this Order, where—
