I hereby certify that, in compliance with the requirements of Section 56 of the Planning Act 2008 –

- (a) notice of the accepted application was given to the required persons identified in accordance with section 56;
- (b) a copy of the accepted application and accompanying documents and information was made available to the required persons; and
- (c) the accepted application was published in the required manner

in relation to the application for an order to grant development consent for the A46 Coventry Junctions (Walsgrave) Scheme (the “Scheme”), which would authorise the alteration of a section of the A46 and B4082. The Scheme is located within the county of Warwickshire, to the east of Coventry, and within the Coventry City Council and Rugby Borough Council administrative areas.

The deadline date for all representations to be received by the Planning Inspectorate under section 56 was 27 February 2025 at 11.59pm.

During the relevant representation submission period, five letters were returned to sender, and the Applicant had to serve notice at a later stage. The relevant representation period did not need to be extended for these interested parties affected to ensure they were given 30 days to respond, as the letters reached the parties with at least 30 days of the relevant representation period remaining.

However, in the case of one interested party, the relevant representation period had to be extended to 8 March 2025 due to them receiving a late notice, and for seven interested parties, this had to be extended to 28 March 2025.

These parties notified later are set out in the schedule sent alongside this certificate (Appendix 1).
