## A46 COVENTRY JUNCTIONS (WALSGRAVE) – TR010066 DEADLINE 5 COVERING LETTER

National Highways (the "Applicant") is responding to Deadline 5 of the Examination and submitting documents required by the Examining Authority (the "ExA") in its Rule 6 (**PD-006**) and Rule 8 (**PD-007**) letters, as well as other documents it believes are required to complement and assist in the Examination.

The Applicant acknowledges the ExA's Rule 17 letter and appreciates that the ExA has proposed a shorter examination. The Applicant has responded to the ExA's Rule 17 letter in 8.25 Applicant's Response to the Examining Authority's Rule 17 Letter 31 July 2025, submitted at this Deadline.

## **Documents submitted at Deadline 5**

Table 1 provides a complete list of all documents being submitted by the Applicant at Deadline 5 and the reasons for their submission. The documents are submitted in clean and tracked change versions if they are updated versions of existing documents. The updated Statements of Common Ground are submitted as clean versions only.

## Finch Case

Despite climate change not being a topic raised by the ExA in their 31 July Rule 17 request or earlier in the examination, the Applicant has submitted a statement on the implications for the project of the Supreme Court *Finch* judgment, as the Applicant believes this will reduce the risk of subsequent legal challenge to the making of the Development Consent Order should the Secretary of State decide to approve it. This has been provided at Deadline 5 and given the potentially shortened timetable, the Applicant requests that it is published as soon as reasonably practicable to maximise the opportunity for other parties to comment on it.
