National Highways (the “Applicant”) is responding to Deadline 7 of the Examination and submitting documents to complement and assist in the Examination.

The Applicant acknowledges Natural England’s Summary Statement (**REP6-027**) submitted at Deadline 6, however the Applicant’s position has not changed from previous deadlines and as set out in final Statement of Common Ground with Natural England (**REP6-021**), submitted at Deadline 6. The Applicant provided a full response to Natural England’s comments on noise matters (**REP4-027**) in the Applicant’s Comments on Submissions Received at Deadline 4 (**REP5-020**).

**Documents submitted at Deadline 7**

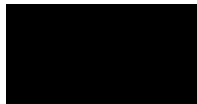
The Applicant acknowledges the late Deadline 6 submission by Osbourne Clarke on behalf of National Grid Electricity Distribution (East Midlands) plc (“NGED”) and National Grid Telecoms Limited (“NG Telecoms”). The Land and Rights Negotiations Tracker (**REP6-016**) has been updated and submitted at Deadline 7 to provide an update on the negotiations and agreements for NT Telecoms. There has been no change for the position set out for NGED. The Applicant has also updated the position with Vodafone.
