Dear Mr Miliband,

I am writing to you as the Secretary of State for Energy Security and Net Zero, to urge you to persuade the Secretary of State for Transport to refuse the application by London Luton Airport for a huge expansion, from 19 million to 34 million passengers a year. In 2021 the Climate Change Commission, advised the Government that to attain Net Zero by 2050, there should be no further expansion of the UK Airports. If this expansion is allowed to go through it will blight many people's lives near the flight paths and have a very negative affect on the environment and countryside. Once allowed it cannot be reversed.

Luton Airport have made efforts to reduce their carbon footprint on the ground within the Airport; but the mitigation of noise levels and carbon footprint of the planes (in spite of the new so-called quieter aircraft) has been negligible.

So please do not allow your efforts to reduce the carbon footprint of the UK and expand green energy, to be countered by the Airline industry, who currently do not have much quieter or greener aircraft to justify a huge hike in their numbers.

I am a local Borough Councillor, in Hertfordshire, whose ward is affected by noise and environmental pollution from overflying aircraft from Luton. I am also a member of LADACAN
