
Methodology

- Excel spreadsheet containing all RRs received was provided on request by UK Planning Inspectorate, as per email dated 28/1/19 ¹
- 2. Every RR received was initially read manually by JJH and tagged as either "For" or "Against" the DCO, or "Neutral". Representations were tallied as follows:
- 3. Master spreadsheet subdivided into "For", "Against' and "Neutral" sheets

"Neutral" RRs include:


- Some statutory bodies with comments, concerns and/or recommendations but no clearly defined support or opposition, (e.g. Natural England RR-1408, Met Office RR-1168 etc.)
- RRs where position of respondent is unclear or undefined or requires assumptions to be made (e.g. RR-0371, RR-1110, RR-1422, R-1908, RR-1976 etc.)
- RRs where respondent discusses both pros and cons with no clear conclusion, (e.g. Supporters of Manston Airport RR-1890, RR-1651, RR-1402 etc.)
- RRs where respondent has merely declared themselves as an interested party, (e.g. Heathrow Airport Ltd, RR-0660, RR-0567, RR-0702, RR-0788 etc.)

All categories include **organisations**, each of which have been counted as a single RR, as follows:

- 68 organisations AGAINST the DCO
- 20 organisations FOR the DCO
- 17 NEUTRAL organisations



5. Identifying Principal Issues



- 5.1. Principal issues raised by respondents "Against" or "For" the DCO were initially manually identified as recurring themes in the RRs
- 5.2. Keywords associated with each of the principal issues were created and grouped together, e.g. "Climate Change" includes references to keywords of "climate change", "environment" and "pollution"
- 5.3. Formula created in each spreadsheet to search for keywords associated with each of the "For" and "Against" principal issues and assign a "TRUE" value in cell if keyword(s) was mentioned, (or "FALSE" if not mentioned)
- 5.4. Number of RRs mentioning grouped keywords tallied to give a total number of RRs for each of the principal issues "For" and "Against", as per tables below
