- 7.1 The ExA has not requested any further information under Rule 17 to date.

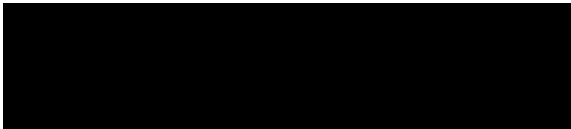
