The Committee of the volunteer group Save Manston Airport association note that the limited company FIVE10TWELVE LIMITED (Company number 08412137) have continued their attack on the RiverOak Manston Airport DCO application, and have written to the National Planning Inspectorate alleging "that members of SMAa are being paid to make representations to the Examining Authority".

Nothing could be further from the truth. SMAa members have certainly not been paid to make representations, the reverse is the case: the SMAa Committee have raised many thousands of pound in voluntary donations from the membership, in support of newspaper and web adverts, and for printing and commercially delivering flyers through doors.

We read ManstonSave's comment as just saying that some members of SMAa have day jobs which require them to submit representations to PINS and that they will do so in support of the RiverOak DCO.

Finally, we will just note that the quote from the twitter thread that FIVE10TWELVE LIMITED sent to the Inspectorate was highly selective, as can be seen below.
