Dear Mr Mackinlay

I write to express my considerable concern that there may be Russian money lined up for investment in the redevelopment of Manston Airport.

As I understand it, the newly proposed register of investors in property will expose any hidden Russian interests in property in the UK.

It is vital that we here in Thanet should under no circumstances be exposed to the white elephant which Manston would become, should it come to light that the on-going development of the cargo hub is dependent on monies rendered unavailable by sanctions. Additionally, it seems the current plans are that this proposed register will be applied retrospectively to cover investments in the 20 years prior to its enactment.

Under such circumstances it will be best for all concerned to be absolutely certain that the monies invested thus far in RSP via the various shell entities in the BVI will not fall foul of the sanctions so correctly (if belatedly) applied by this government.

I shall be writing direct to the Secretary of State for Transport, to Chris Bryant MP, to the Chancellor of the Exchequer and to all other local MPs to raise this same point with them and draw their attention to the fact that the investors are at present hidden from scrutiny. I am sure you will agree that, given Russia's unjustifiable invasion of Ukraine and on-going breaches of human rights, it is vital we in the UK work together to ensure that no Russian money can be laundered or otherwise sequestered here.

Perhaps now is the time for all those planning to invest in Manston Airport to come out into the open so that everyone can satisfy themselves that the money has no associations of which Thanet MPs and Councillors could possibly be ashamed.
