Warnham Parish Council welcome this opportunity to comment further as a parish to the west of the airport impacted by three departures routes and all the final approach (ILS) traffic as such no respite for the northern section of our parish.

As per our submission during the DCO hearings noise remains to be a major concern for our parishioners as is the fact that the modernisation of airspace was not included in the hearings. We continue to believe, along with the local authorities, that Gatwick requires FASIS to meet their economic predictions of aircraft movements as such our parish could be significantly impacted and devalued. Although we welcome the SoS response to include insulation from the outset our parish will not benefit from this although significantly impacted. We are therefore disappointed that with a new runway there is no compensation for loss of house value as a new runway and FASIS potentially will devalue our highly sort after historic parish properties and impact the wellbeing of our parishioners.

Our parish will also be outside of the noise contours identified by the SoS and the proposed noise envelope.

We remain concerned over waste and the transportation of by the airport to incinerators as they have now removed their onsite incinerator. We request again that the movements and the emissions from such should be included in scope 3 emissions and not scope 2 and reference the new SoS ruling on Riverhall Integrated Waste Management Facility and Energy Centre Scheme October 2024. As a new incinerator is due to be built on the boundary of our parish we re-iterate our concerns that if this is to be used by the airport that there are no stringent sections of the DCO to cover this in both lorry movements on already congested roads and emissions. We have endeavoured to engage with WSCC on this but they do not have the data or forecasts.

As to the Transport Forum, our parish has never been invited to attend such a forum as such we must question its adequate liaison process to the true, far reaching, ramifications of the airports operations now, or with a new runway.

We would like to take this opportunity to support the Thames Water requests for staggering of growth as well as request that it be mandatory for an onsite wastewater treatment plant at the airport and that the airport should be active in working with the Environment Agency to achieve this before dual operations.

We also welcome the comments from Network Rail and subsequent suggestions on restrictions is sustainable transport plans are not met.

An area that our council highlighted is not mentioned in this request from interested parties

or by the applicant as such we wish to re-iterate our concerns over the decline in air quality as such we wish to support and highlight the expert reports submitted by CAGNE.

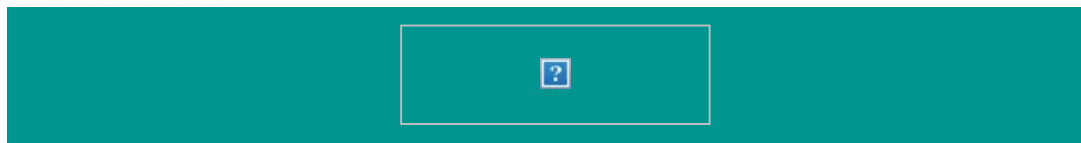
