As a resident (Interested Party) who lives close to Gatwick Airport (Copthorne village) and who will be directly impacted by further development, I write to strongly object to the new runway for the following reasons:

The applicant (Gatwick Airport) is failing to abide by the planning process, by introducing a third scheme outside of the examination time frame. I urge the Secretary of State to demand that noise and surface transport be re-examined and that the planning process be halted and re-instigated, to allow for full and transparent examination of the facts to ensure Gatwick Airport's new runway does not further increase the already catastrophic risks of climate change.

With average temperatures already exceeding the 1.5 degrees which the UK committed to remain under the Paris agreement. Crazily, the present government has now back-tracked on their commitment to act seriously and urgently to mitigate, this huge and ever increasing risk. It seems altogether ridiculous as we are at such a perilous point in history for the government to act in direct opposition to the long term interests of it's entire electorate, climate change will impact and is already impacting every individual on Earth. This government can begin to shift the balance, instead they are playing a game they WILL lose and history will show them to be negligent, reckless & mindless in their duties to their electorate.

At Gatwick, they are already on stage 3 of the 7 stages of the consultation process and will hand over all work to date (which is extremely flawed) to UKADS. I strongly object to the way this process has been handled without meaningful and accessible mechanisms for communities to be properly consulted.

Night flights are of increasing concern, Gatwick has seen an increase of these particularly in the early morning hours, causing local communities to suffer sleep disturbance which

has a knock-on effect on both physical and mental health. Day time noise pollution is also on the increase as stated in a report by the CAA, further impacting those who have the misfortune to live close to the airport.

How can any sane person think that with the current state of global warming there can be any valid case for INCREASING aircraft traffic? This is the most polluting form of transport and is elitest, with the vast majority of the world's population never flying.
