### APPLICATION FOR THE PROPOSED ABLE MARINE ENERGY PARK

The Health Protection Agency (HPA) notes that although the 'Scoping Opinion – Web Version' cites the HPA as being consulted and as replying within the given period, an assessment of the health impact of human exposure to electric, magnetic and electromagnetic fields (EMF) resulting from the Able Marine Onshore Windfarm project is not apparent in the Application documents. HPA would expect to see this assessment in the Environmental Impact Assessment (EIA).
