2	Applicant confirmed that they will provide the final versions of the following documents at Deadline 6 to help with the preparation of the RIES: • Habitats Regulations Assessment (HRA) (and confirmation that Package 1 has fallen away and Package 2 can be implemented); • Environmental Statement (ES); • Avon Gorge Vegetation Management Plan (AGVMP); • Signed Statement of Common Ground	Applicant	Deadline 6	The HRA and the AGVMP have been amended to confirm that Package 2 and the woodland habitat compensation measures will be delivered on Forestry Commission land unless the SoS directs otherwise. The recent Government Guidance on Habitats Regulations Assessment has been incorporated within the HRA and applied to the DCO Scheme. As a result, it is no longer necessary to submit the separate HRA road map envisaged at ISH5. Where updates to ES Chapters have been made these will be submitted, together with amended Appendices. All documents submitted will be in the form to be certified except for the Reptile and Toad Mitigation Strategy, which will be submitted in draft for DL6 and in final form for DL7. It is intended that all documents listed, except for the HRA roadmap (which is no longer needed) will be provided by 5pm on 16 March 2021.
