In article 51(1)(a), (b) and (c) for "Her Majesty" substitute "His Majesty".

<u>Secretary of State's rationale</u>: To reflect the change of monarch from Queen Elizabeth to King Charles.

Correction to Schedules

Schedule 16 (protective provisions), Part 5, Protection for First Corporate Shipping Limited

In paragraph 50(1) and (2) replace "highways access land" with "highway access land".

<u>Secretary of State's rationale:</u> to correct a referencing error.

Schedule 16 (protective provisions), Part 5, Protection for First Corporate Shipping Limited

In paragraph 50(3)(e) for "use f land" substitute "use of land".

Secretary of State's rationale: to correct a typographical error.

Schedule 16 (protective provisions), Part 8, National Grid as Electricity Undertaker

In paragraph 90, in paragraph (a) of the definition of "specified works" and paragraph 98(2), (6) and (9) for "existing apparatus" substitute "apparatus".
