# The Portishead Branch Line (MetroWest Phase 1) (Correction) Order 2025

Made - - - - 16th October 2025

Coming into force 17th October 2025

The Portishead Branch Line (MetroWest Phase 1) Order 2022 ("the 2022 Order")(a), which granted development consent within the meaning of the Planning Act 2008 ("the Act")(b), contained correctable errors within the meaning of paragraph 1(3) of Schedule 4 to the Act.

In accordance with paragraph 1(5)(a) of Schedule 4 to the Act, before the end of the relevant period, as defined in paragraph 1(6)(a) of Schedule 4 to the Act, the Secretary of State received a written request from the applicant(c) for the correction of errors and omissions in the 2022 Order.

In accordance with paragraph 1(7) of Schedule 4 to the Act, The Secretary of State has informed the relevant local planning authorities for the area in which the land to which the 2022 Order relates is situated, that the request has been received.

The Secretary of State, in exercise of the powers conferred by section 119 of, and paragraph 1(4) and (8) of Schedule 4 to, the Act, makes the following Order.

#### Citation and commencement

1. This Order may be cited as the Portishead Branch Line (MetroWest Phase 1) (Correction) Order 2025 and comes into force on 17th October 2025.
