Proposed Strategic Rail Freight Interchange (SRFI) at land east of Heyford Park and south of the Chiltern Railway line – Stage 1 consultation

Oxfordshire Railfreight Limited ('the Applicant') is proposing a Strategic Rail Freight Interchange (SRFI) close to Junction 10 of the M40 motorway, and is now commencing a first stage of public consultation about the emerging proposals.

Please find the enclosed community awareness leaflet which is being distributed across a wide area in the vicinity of the proposed site, including in areas which you represent. The leaflet has been prepared to ensure that local communities are aware of the wide range of ongoing work, and of the programme of activity planned over the coming weeks.

As set out on the information provided, the consultation period **begins on 9th May 2022** and includes four consultation exhibitions which are being held from 12th May 2022. We are also holding two online webinars.

The issues and comments raised during this initial consultation and engagement activity will feed directly into the ongoing process of refining the proposals alongside the ongoing technical assessment work which will form part of the application for a Development Consent Order in due course.

We appreciate that one of the most common topics for questions and requests for detailed information will be with regard to the transport impacts, including the proposed improvements to Junction 10 of the M40. Our consultation material presents our emerging preferred proposals, informed by dialogue with National Highways and Oxfordshire County Council, but that preliminary scheme is to be subject to testing using the agreed transport model for the area over the summer and beyond. The highways modelling will provide a full picture of the likely transport impacts of the proposed development in the context of the traffic it would generate alongside traffic generated by other 'committed' developments nearby. The modelling process will provide a clear understanding of the likely transport impacts, and of any mitigation measures required above and beyond those already being proposed.

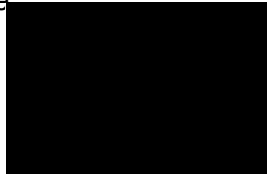
Once we have a fuller understanding of the transport impacts, we will be able to use data generated by the modelling to undertake the detailed noise and air quality impact assessments which will also form part of the final Environmental Statement. Beyond highways, on-site survey and assessment work remains ongoing. For example, ecology, geophysical surveys (archaeology), and ground condition surveys. Our consultation material includes initial information from the preliminary work undertaken to date on a range of environmental and other topics.

The current expectation is that we will hold our statutory (Stage 2) consultation during the winter of 2022/early 2023. By that time we expect to have a full draft set of Environmental Statement chapters which we will share as part of the consultation process, alongside a range of other information relating to the proposals.

The timing and nature of that second stage of consultation remains unconfirmed at present, but we will be in touch again nearer the time to provide details once known. However, based on our current programme, we anticipate submitting an application for Development Consent in 2023. We will also ensure the project website is updated with new information once available <https://oxsrfi.co.uk/>.
