1 Guide to the Application

1.1 Guide to the Application Overview

Purpose of this Document

- 1.1.1 This Guide to the Application document summarises the structure of the application for development consent made by Southern Water Services Limited (hereafter referred to as 'the Applicant') to the Planning Inspectorate for the Hampshire Water Transfer and Water Recycling Project ('the Project'). It explains what the documents are and provides an understanding of the structure of the Applicant's application, and the principal contents within each volume of documents.
- 1.1.2 This document functions as an accessible guide to the Project, the Applicant and the application, and will assist those in reviewing the application documentation. It is intended that the document be updated as the examination of the application proceeds.

1.2 Hampshire Water Transfer and Water Recycling Project

The Project

- 1.2.1 The Project comprises the construction, operation and maintenance of the following components:
- Water Recycling Plant and associated pumping stations.
 - Pipelines between Budds Farm Wastewater Treatment Works and the Water Recycling Plant site.
 - Pipelines between the Water Recycling Plant site and Bedhampton Springs, connecting to pipelines being delivered by Portsmouth Water between Bedhampton Springs and Havant Thicket Reservoir.
 - Pipeline between the Water Recycling Plant site and Otterbourne Water Supply Works.
 - Above Ground Plant comprising Intermediate Pumping Stations and Break Pressure Tanks located along the Pipeline between the Water Recycling Plant site and Otterbourne Water Supply Works.
- 1.2.2 The Project would also comprise the use of the following infrastructure:
- Havant Thicket Reservoir (which has been consented separately by Portsmouth Water and is currently under construction) for the storage of recycled water.
 - The existing Eastney Long Sea Outfall, Eastney Pumping Station, and associated Eastney Transfer Tunnel for the release of reject water from the WRP site.

- Pipelines and other related works (which have been consented separately by Portsmouth Water) for the transfer of recycled water and source water between Bedhampton Springs and Havant Thicket Reservoir.
 - The construction and operation of the Project would be supported by other temporary and permanent works.
- 1.2.3 The Project will require the demolition, disassembly and/or temporary relocation of a number of small structures.
- 1.2.4 A detailed description of the Project can be found in ES Chapter 3 Description of the Proposed Development, Volume I (Document reference 6.1, DCO Volume 6). The Application Glossary (Document reference 1.7, DCO Volume 1) sets out the abbreviations and definitions used in the DCO application for the Project.

1.3 Application Documentation Overview

- 1.3.1 The reports, drawings and plans that make up the application for development consent have been organised into seven volumes as listed in Table 1-1. The seven volumes are explained in more detail in section 1.4.

5.6	Case for the Project	This document identifies and sets out the need and case for the Project against relevant legislative and policy tests as well as reporting on the Project legacy and benefits, and how the Project delivers value for money in the context of the Applicant's Water Resources Management Plan.
5.7	Potential Main Issues for Examination	The document outlines the principal areas of disagreement between the Applicant and stakeholders during the pre-application stage of the Project's application. It provides the Examining Authority with a summary of these issues, reflecting ongoing discussions and the current positions of stakeholders and the Applicant.
5.8	Draft Statements of Common Ground	These documents are prepared for identified stakeholders (as set out in Table 1.9 and the Electronic Application Index (Document reference 1.5, DCO Volume 1)) involved in the Project to outline matters of agreement or disagreement with the Applicant. 7.14	Protected Species Licensing	Includes the draft protected species licence applications for badger and hazel dormouse which set out how licensable work and mitigation will be delivered for the project. It also includes Letters of No Impediment for each of these applications which confirm that Natural England envisages no obstacles to the licences being granted on full application prior to the start of construction. A District Licence Report from NatureSpace is also included, which confirms that a District Licence can be issued for the Project and sets out the context that has been used by NatureSpace to establish this.
