



1 Introduction

- 1.1.1 The Land Plans (the Plans), listed in Table 1.1, relate to an application made by Anglian Water Services Limited (the "Applicant") under section 37 of the Planning Act 2008 (the "2008 Act") for a Development Consent Order (DCO) for the Cambridge Waste Water Treatment Plant Relocation Project.
- 1.1.2 The Plans are included in the DCO application in compliance with Regulation 5(2)(i) of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (the "2009 Regulations"), which require:
 - "5(2) The application must be accompanied by—
 - (i) a land plan identifying—
 - (i) the land required for, or affected by, the proposed development;
 - (ii) where applicable, any land over which it is proposed to exercise powers of compulsory acquisition or any right to use land;
 - (iii) any land in relation to which it is proposed to extinguish easements, servitudes and other private rights;"
- 1.1.3 As these Plans are part of the application documentation, they should be read alongside and are informed by the other application documentation. In particular, these Plans should be read alongside Schedule 1 (Authorised Development) of the Draft Development Consent Order (Application Document Reference 2.1) and the Works Plans (Application Document Reference 4.3).


2 Changes to parcels 019a, 019k, 019l and the addition of 019n




2.1.2 At Deadline 5 the Applicant has submitted amended Sheets 3 and 7 of the Land

which was submitted at Deadline 1.

















